Dear Friends,

As we look back on 2025, we do so with gratitude and hope. Across Europe, JRS continued accompanying refugees and forcibly displaced people through programmes and initiatives that promote protection, inclusion, advocacy, and community engagement, ensuring that people on the move are met with dignity, solidarity, and care. Together, our network supported more than **187.567 people** across **23 countries** and over **240 locations**.

We continued responding to the needs of refugees affected by the war in Ukraine, accompanied people in detention, promoted opportunities for inclusion and participation, strengthened our advocacy efforts at both national and European levels, and engaged young people and communities in fostering greater awareness, solidarity, and active citizenship.

This year also marked an important step in shaping our future as we worked together across the network to develop a new Strategic Framework. It reflects our shared commitment to building more welcoming communities and advancing justice, reconciliation, and human dignity across Europe.

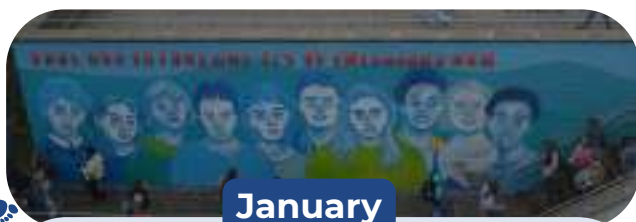

February

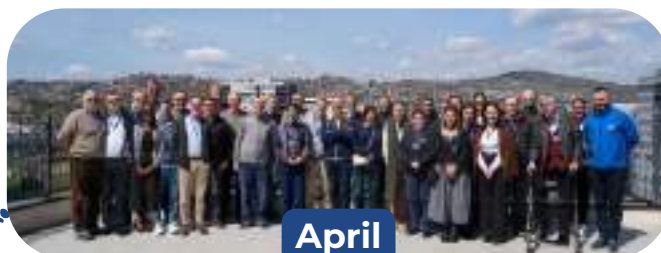
One Proposal Annual Report

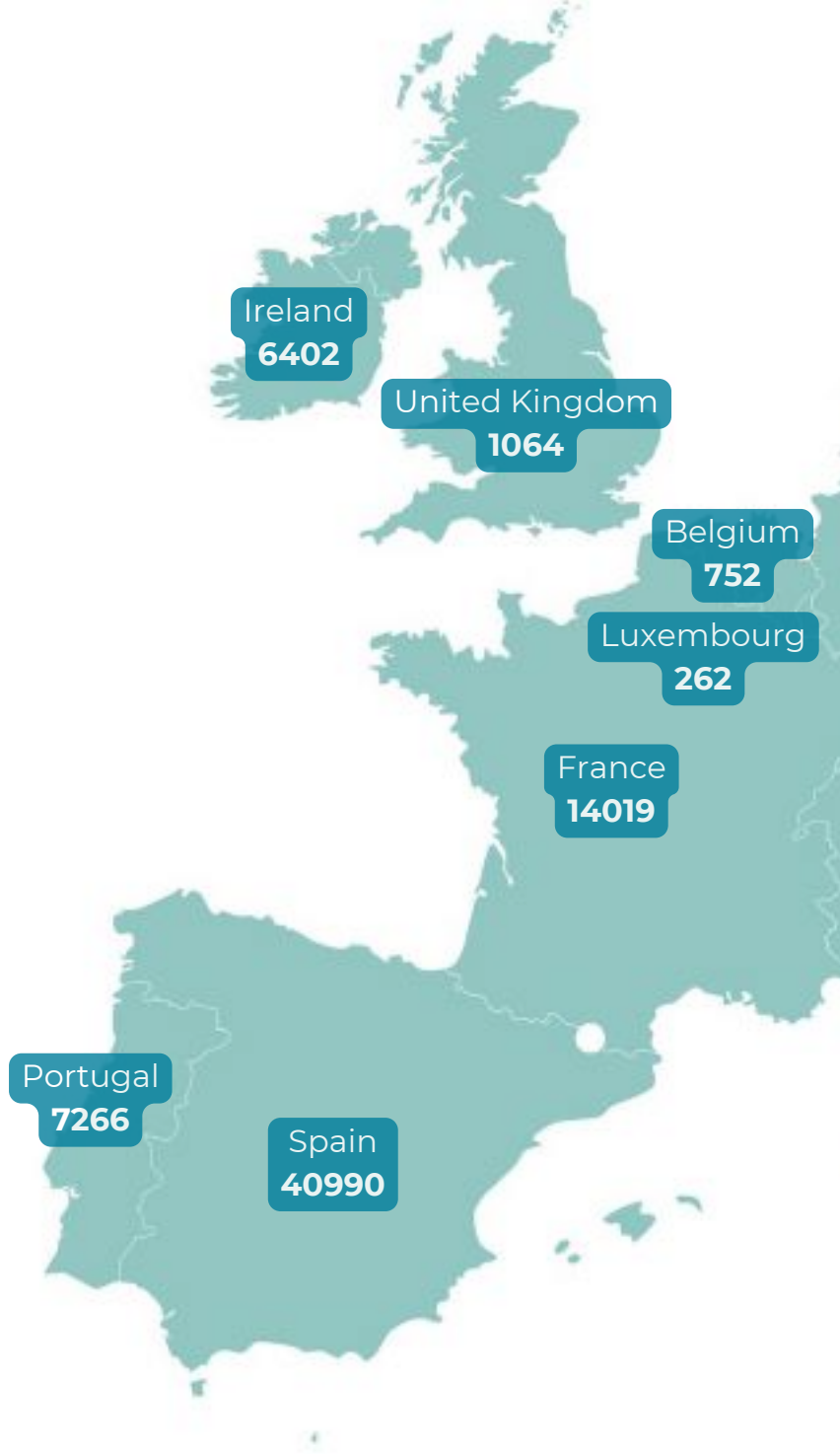

Promoting access to protection, rights, and meaningful participation for forcibly displaced people, while fostering welcoming and inclusive communities across Europe.

Agency

Supporting people and communities in reclaiming autonomy, developing opportunities, and shaping their own future with dignity and hope.

Reconciliation & Justice

Building communities rooted in solidarity, encounter, and social transformation, while promoting justice, dialogue, and shared responsibility.

SMART UA

Scaling the successful social inclusion and integration of Ukrainian refugees in Hungary, Romania and Slovakia through an innovative multi-stakeholder cooperation



The SMART UA project, funded by the European Social Fund Plus and Social Innovation, supports Ukrainian refugees in Hungary, Romania, and Slovakia. Coordinated by JRS Europe with 11 partners, it fosters collaboration among authorities, NGOs, and service providers to improve access to housing and jobs through skills recognition, capacity building, and innovative pilot initiatives.



JRS Europe will coordinate the project. Core partners include **JRS Hungary, JRS Romania, Lutheran Diaconia, Szociometrum, LifeStarter**, the **Family Help Center**, and the **Association of Schools of Social Work in Romania**. They are joined by associated partners such as Trnava University, the City of Trnava, and Personal Service, who contribute research, local expertise, and labour market connections. Based across **Hungary, Romania, and Slovakia**, these partners combine social, academic, and community strengths to support refugee integration.

Research & Analysis

National reports identifying barriers and innovative practices in housing and employment.

Capacity Building

Workshops and local trainings engaging 90–150 stakeholders across the three countries.

Cooperation

Connecting NGOs, local authorities, social institutions, and employment actors.

European Exchange

Promoting transnational learning and exchange through a final event in Brussels.

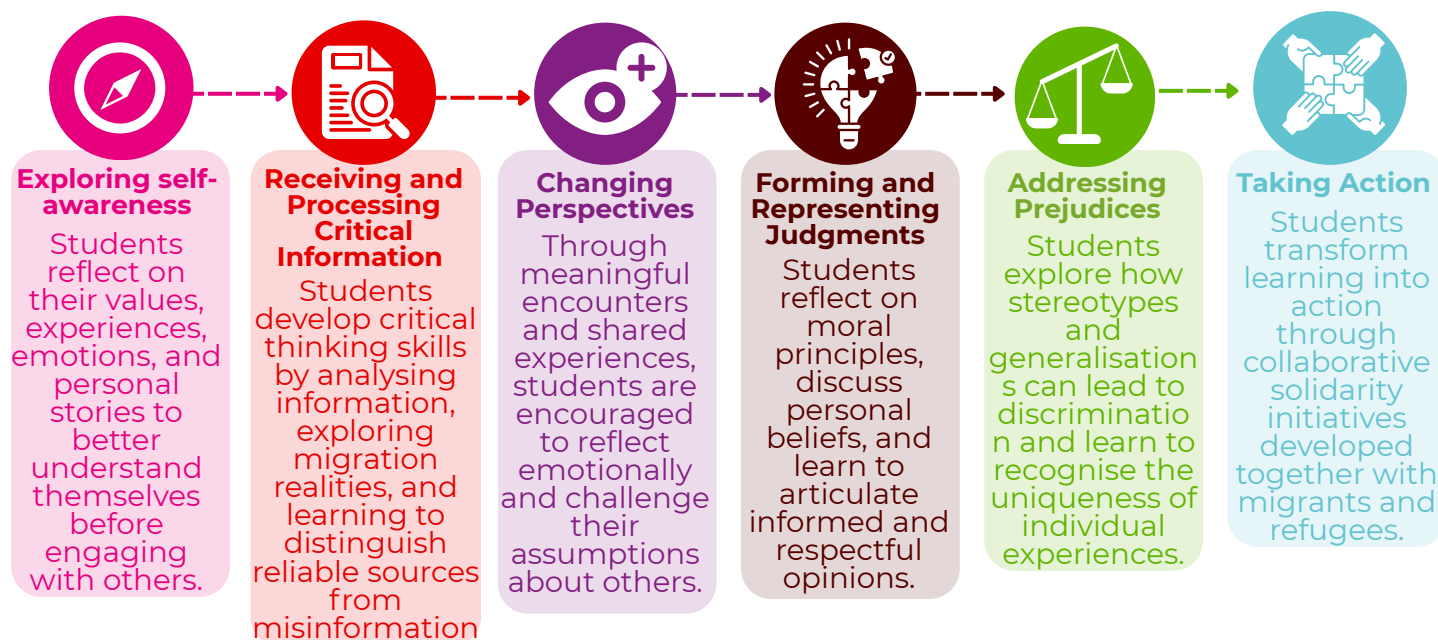


TOGETHER FOR CHANGE



Together for CHANGE is a project coordinated by JRS Europe and implemented in **Belgium, Spain, Greece, Croatia, Hungary, Italy, Serbia and Portugal**. The goal of the project is to foster students' civic engagement **to promote critical thinking skills and migrants' integration** by encouraging students to take actions together with young migrants to participate in schools and community initiatives.

To support schools in addressing migration, diversity, and participation in meaningful ways, Together for Change developed a flexible pedagogical curriculum adapted for students **under and over 15 years old**. Structured around six interconnected stages, the curriculum was translated into **11 languages** and implemented across participating countries, providing teachers and students with practical tools **to foster critical thinking, empathy, dialogue, and active citizenship** through shared learning experiences.

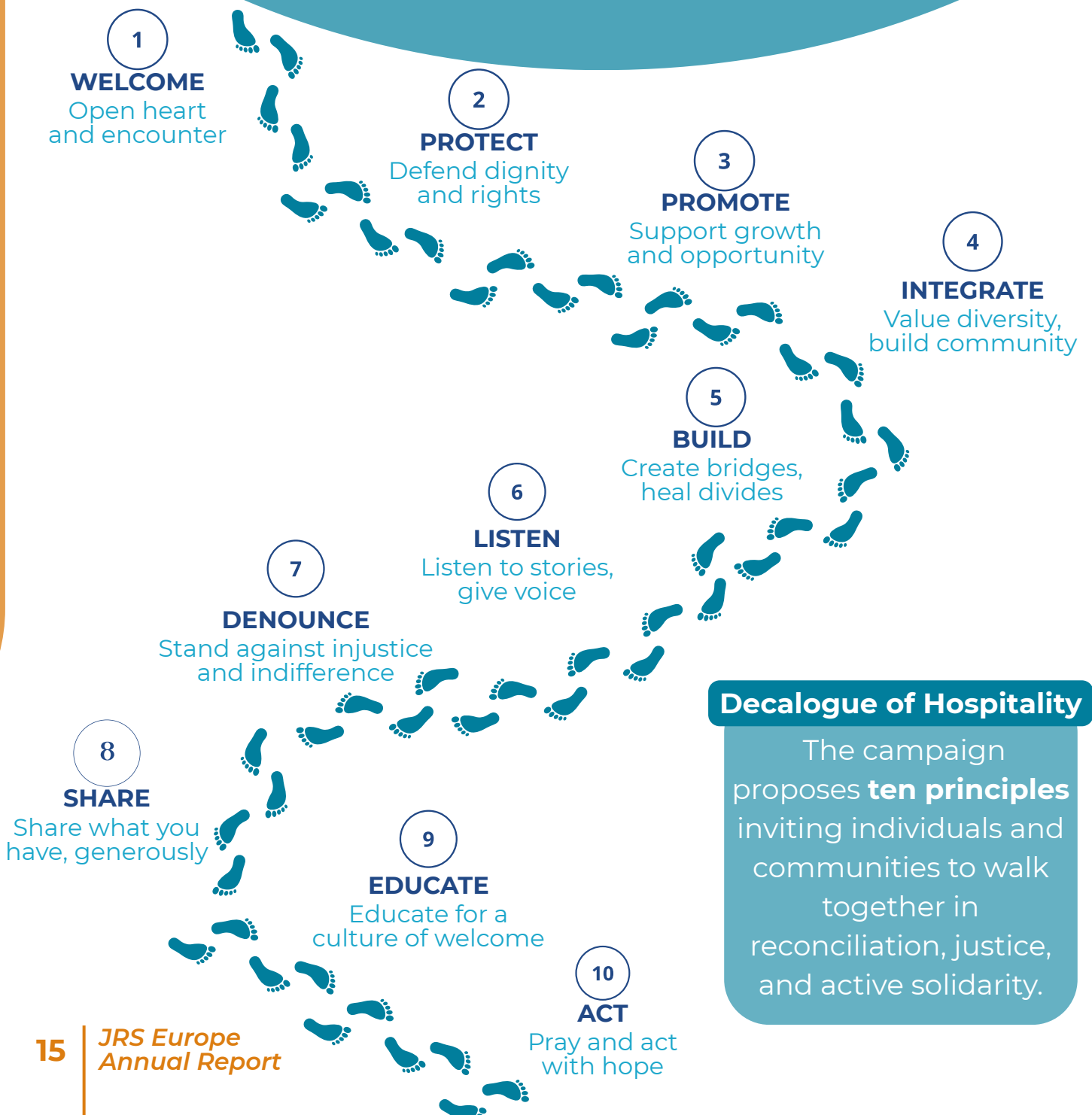

Paths of Hospitality is a global campaign promoting a culture of **solidarity, encounter, and inclusion** with people forced to migrate. Inspired by the legacy of Jesuit priest Frans Van der Lugt, whose walks with young people of different backgrounds symbolised **peace, coexistence, and shared humanity**, the campaign encourages communities **to reject indifference and build welcoming spaces** rooted in dignity, dialogue, and hope.

Learning from One Another

Across the JRS Europe network, country offices develop **innovative responses** to the challenges faced by refugees and migrants in their local contexts. Rooted in our **Strategic Framework** and shared mission, these initiatives demonstrate how **accompaniment, hospitality, protection, and inclusion** can be translated into **practical action**. The following examples highlight approaches that have **strengthened communities, promoted dignity, and generated lasting impact** while offering inspiration for replication across the network.

1 Women's Day Center, JRS Greece

A safe and holistic space supporting refugee and migrant women through psychosocial and legal assistance, childcare, hygiene services, and access to essential goods. By addressing immediate needs while strengthening autonomy and community belonging, the centre promotes dignity, and long-term inclusion.

Since spring 2023, JRS organizes monthly guided visits to museums, historical sites, cultural landmarks and places of religious heritage.

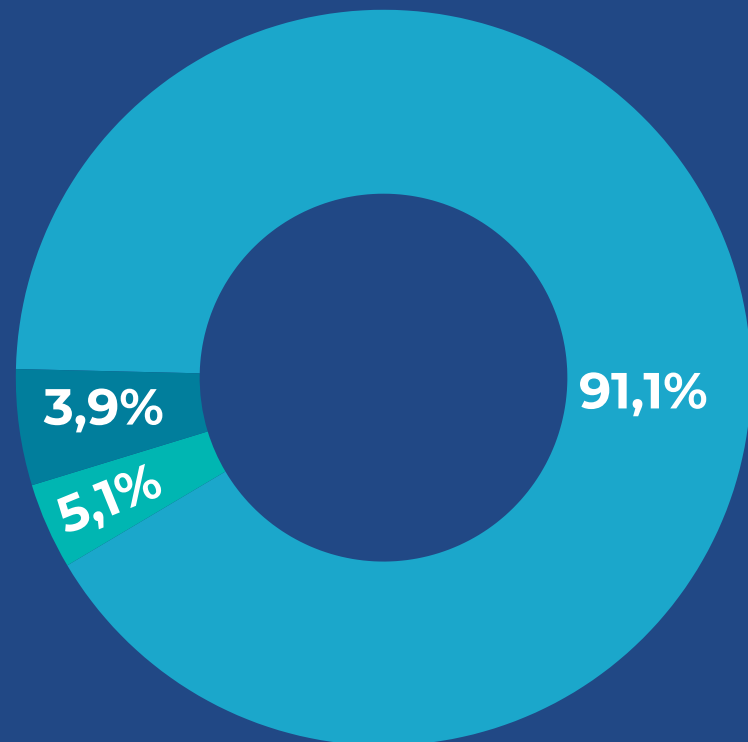

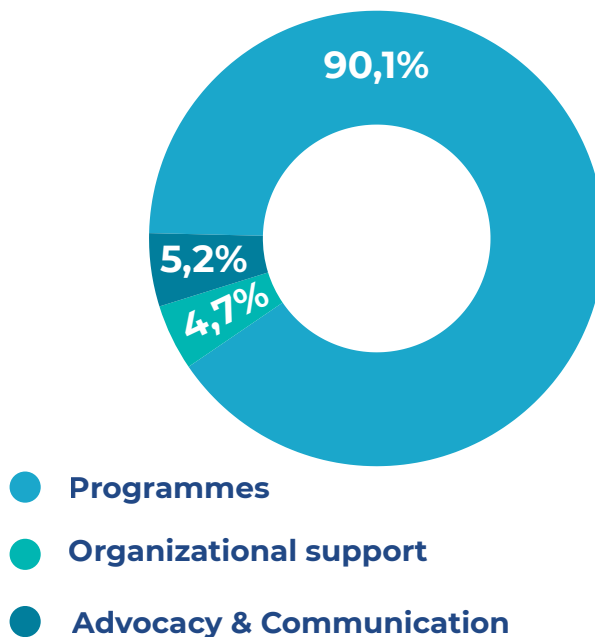
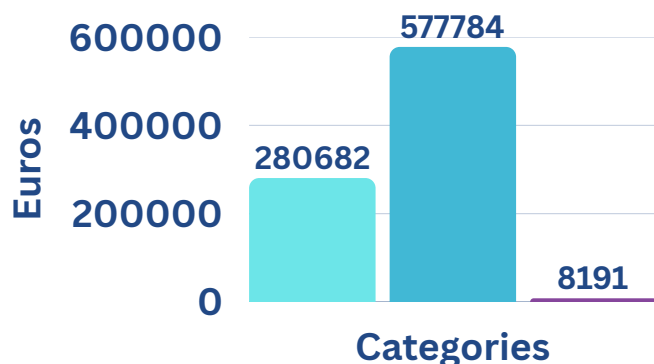
